## City of Macclenny, Florida CDBG-MIT General Infrastructure Program Public Notice

The City of Macclenny will be applying to the Florida Department of Economic Opportunity (DEO) for Community Development Block Grant - Mitigation (CDBG-MIT) funding through the Rebuild Florida General Infrastructure Program. A total of \$475,000,000 is being made available through a competitive application process for eligible local governments. Eligible applicants can submit project applications for a minimum of \$2,000,000 per application. A maximum of \$175,000,000 per application is available for eligible activities. Eligible activities include projects that demonstrably increase community resilience. Examples of eligible activities include, but are not limited to, the following:

- Restoration of critical infrastructure (such as water and sewer facilities, streets, drainage, bridges, etc.).
- Renourishment of protective coastal dune systems and state beaches.
- Building or fortifying buildings that are essential to the health, safety and welfare of a community.
- Rehabilitation or construction of stormwater management systems.
- Improvements to drainage facilities.
- Reconstruction of lift stations and sewage treatment plants.
- Road repair and improvement and bridge strengthening.

The City will be requesting up to \$175,000,000 in CDBG-MIT funding to undertake projects that will enhance the resiliency of both the City's Water System and Wastewater System, as well as restore and improve critical infrastructure within these systems.

The Water System project is expected to include major upgrades at one of the City's Water Treatment Plant (WTP), which will provide improved fire protection, adequate system pressures, and increased capacity system-wide. The project will also replace deteriorating and undersized water mains throughout the distribution system, extend distribution system lines to provide potable water and fire protection to previously unserved homes and account for near-term growth, and connect existing water mains to "loop" the system and eliminate dead-end lines. The goal of this project is to provide improved accessibility and much needed redundancy to this critical infrastructure to all proposed beneficiaries in the event of a major disaster.

The Wastewater System project is expected to include the full rehabilitation and/or replacement of existing gravity sewer and associated components, much of which is deteriorated, cracking, collapsing, or has exceeded its useful life. Restoration of this existing critical infrastructure is paramount to avoid collapsing roadways and sewer backups and/or overflows, which the City has continued to battle in recent years. The collection system is even more at risk during major disasters, as condition of the pipes allow for significant stormwater infiltration, overwhelming the system's capacity. The project will also fully rehabilitate and upgrade existing lift stations, as well as construct new force mains, to increase capacity and maintain the ability to serve existing and new customers south of I-10. The new force mains will either connect to existing force mains or connect directly to the City's Wastewater Treatment Facility (WWTF) so that the rehabilitated lift stations are not reliant on other lift stations or gravity sewer lines to transmit wastewater to the WWTF. This is essential, particularly during disaster scenarios when certain areas lose power or sewer collapses occur. Together, the goal for this wastewater system project is to mitigate public health and safety concerns related to a failing and undersized collection system, increase and restore system capacities, and to allow for new connections, mitigating flood conditions on existing septic tank systems.

A public comment period running from August 27, 2021, through September 13, 2021 (17 days) will be held for all members of the general public regarding this grant opportunity and how it can be utilized by the City. Additionally, the City will host a virtual public meeting to provide all members of the general public an opportunity to participate within the public comment period on September 13, 2021, at 5:00 p.m. Persons wanting to submit written comments within the public comment period should send them to Melissa K.
